# Suling Hill Development accelerates RM1.3 billion Northern TechValley @ BKE project with key flyover bridge groundbreaking

- Commences construction of RM30 million flyover bridge to boost park connectivity to Butterworth-Kulim Expressway
- Underscores commitment to sustainable, future-ready industrial ecosystem, backed by strong public-private cooperation

Seberang Perai, Penang, Malaysia, 8 August 2025 - Suling Hill Development Sdn Bhd (Suling Hill Development, Suling Hill 发展有限公司), a joint venture between leading industrial space solutions provider AME Elite Consortium Berhad (AME Elite, 腾字集团, Bloomberg: AME MK) and property developer Majestic Gen Sdn Bhd (Majestic Gen, Majestic 集团), reached a new infrastructure milestone for its RM1.3 billion freehold Northern TechValley @ BKE industrial park, commencing construction of a new flyover bridge that enhances the park's connectivity to the Butterworth-Kulim Expressway (BKE).

The RM30 million flyover bridge, a private initiative by Suling Hill Development, spans 413 meters and is a core component of the park's infrastructure. It is designed to accelerate logistics efficiency, ease traffic congestion, and enhance mobility for surrounding communities. This commitment to delivering an integrated, high-performance industrial ecosystem is a key initiative to attract high-tech manufacturing to the state.

At the groundbreaking ceremony, Penang State EXCO for Local Government and Town & Country Planning, YB H'ng Mooi Lye (方美铼) pointed to the success of Northern TechValley @ BKE as a result of strong public-private cooperation. He added that the project is strategically aligned with Penang Structure Plan 2030, positioning it as a catalyst for high-value, innovation-driven industries and driving significant job creation.

Northern TechValley @ BKE, a 176-acre freehold industrial park launched in 2024, is pioneering a new standard for industrial development in the region. Sustainability is a core design principle. Embracing the natural context of Suling Hill and Mengkuang Dam, the park preserves its natural landscape and creates a liveable environment with amenities like a recreational park, outdoor gym, lakeside jogging track and multi-purpose hall with sports facilities.

The first phase of the development officially commenced in July 2025, featuring 1-acre, 1½-storey detached factories. These buildings are purpose-built for high functionality, modern architecture, and operational efficiency, with completion targeted for Q3 2026. The new flyover bridge, designed with a single lane ingress from BKE and a single lane egress to the BKE, will reduce travel time and ease logistics for businesses.
